Moving to Work Demonstration Program (MTW)
Notice of Public Comment Period and Public Hearing

The Houston Housing Authority (HHA) intends to submit a Plan and Application to the US Department of Housing and Urban Development (HUD) to participate in the Moving to Work ("MTW") Demonstration Program pursuant to HUD's Request for Applications (HUD PIH Notice 2020-21). Subject to approval by the HHA Board of Commissioners, the MTW Plan and Application will be submitted to HUD no later than January 8, 2021.

HHA is providing an opportunity for HHA residents, HHA program participants and members of the general public to review and provide comments on the MTW Plan and Application. By noon on Friday, December 4, 2020, the draft MTW Plan and Application will be uploaded can be viewed or downloaded from HHA's main webpage located at: <http://www.housingforhouston.com/>. Due to COVID-19, HHA's principal office building is closed to the public and will remain closed until further notice. As a result, hard copies of these documents are not available for review and inspection at HHA.

HHA will also conduct a virtual public hearing to discuss the MTW Plan and Application and provide opportunities for resident, program participant and general public comment.
